1 Insert the battery pack.

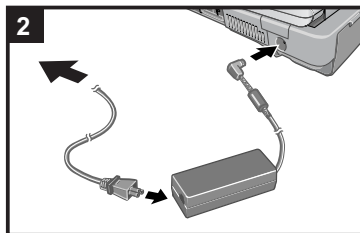
- ① Slide the right latch (A) to the unlocked position (🔓).
- ② Insert the battery pack in the correct direction until it securely fits the connector.
- ③ Slide the right latch (A) to the locked position (🔒).

■ To remove the battery pack

- ① Slide the right latch (B) to the unlocked position (🔓).
- ② Slide and hold the left latch (C) to the unlocked position (🔓), and hold the center of the battery pack and push out in parallel with the bottom surface of the computer.

CAUTION

- Make sure the latch is securely locked. Otherwise the battery pack may fall when you carry the computer.
- Do not touch the terminals of the battery pack and the computer. Doing so can make the terminals dirty or damaged, and may cause malfunction of the battery pack and the computer.

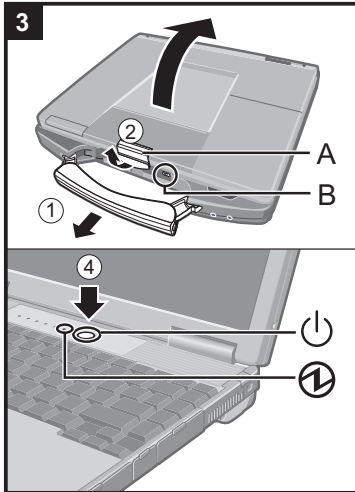


2 Connect your computer to a power outlet.




The battery charging starts automatically.

CAUTION


- Do not disconnect the AC adaptor and do not switch the wireless switch to on until the first-time operation procedure is completed.
- When using the computer for the first time, do not connect any peripheral device except the battery pack and AC adaptor.
- **Handling the AC adaptor**
 - Problems such as sudden voltage drops may arise during periods of thunder and lightning. Since this could adversely affect your computer, an uninterruptible power source (UPS) is highly recommended unless running from the battery pack alone.



3 Turn on the computer.

- ① Pull the carrying handle forward.
- ② Lift up the latch (A) and lift open the display.
- ③ Confirm the wireless switch (B) is off .
- ④ Press and hold the power switch  for approximately one second until the power indicator  lights.

CAUTION

- Do not press the power switch repeatedly.
- The computer will forcibly be turned off if you press and hold the power switch for four seconds or longer.
- Once you turn off the computer, wait for ten seconds or more before you turn on the computer again.
- Do not perform the following operation until the hard disk drive indicator  turns off.
 - Connecting or disconnecting the AC adaptor
 - Pressing the power switch
 - Touching the keyboard, touch pad, touchscreen (only for model with touchscreen) or external mouse
 - Closing the display
 - Turn on/off the wireless switch
- When the CPU temperature is high, the computer may not start up to prevent overheating of the CPU. Wait until the computer cools down, and then turn the power on again. If the computer does not power on even after cooling down, contact Panasonic Technical Support (→ page 35).



4 Setup Windows.

- ① Follow the on-screen instructions.
 - After turning on the computer, “Please wait a moment while windows prepares to start for the first time” appears, and then a small circle circulates on the screen. This will take a few minutes.
 - During setup of Windows, use the touch pad to move the cursor and to click items.
 - Setup of Windows will take approximately 20 minutes.
Go to the next step, confirming each message on the display.

CAUTION

- You cannot choose the following words for user name and password: CON, PRN, AUX, CLOCK\$, NUL, COM1 to COM9, LPT1 to LPT9.
- You can change the user name, password, image and security setting after setup of Windows.
- Remember your password. If you forget the password, you cannot use the Windows. Creating a password reset disk beforehand is recommended.
- The wallpaper for the first logon user has already been set on “4 Setup Windows.”
When using this computer under the Sun, the screen becomes easily viewable by changing the wallpaper to the white wallpaper.
 - ① Right-click on the desktop, and click [Personalize] - [Desktop Background].
 - ② Select [Solid Colors] at [Picture Location].
 - ③ Select the white wallpaper and click [OK].

5 <Only for model with touchscreen> Perform the touchscreen calibration.

- At first, log on to Windows as an administrator, and perform this calibration.
 - ① Click  (Start) - [Control Panel] - [Additional Options] - [Tablet Calibration].
 - ② Using the stylus, touch each of the 9 “+” target marks one by one.
- Perform the following calibration for each user.
 - ① Click  (Start) - [Control Panel] - [Mobile PC] - [Tablet PC Settings].
 - ② Click [Calibrate].

- ③ Using the stylus, touch each of the four “+” target marks one by one, and then click [OK].
 - Perform the calibration for the orientation to be used.

NOTE

● PC Information Viewer

This computer periodically records the management information including the hard disk information such as number of hours powered-on, number of times powered-on, internal temperature, replacement sector. The maximum data volume for each record is 750 byte. These information are only used for estimating the cause when the hard disk goes down by any possibility. They are never sent to outside via network nor used for any other purpose except for the purpose described the above.

To disable the function, add the check mark for [Disable the automatic save function for management information history] in [Hard Disk Status] of PC Information Viewer, and click [OK].

■ When Starting Up/Shutting Down

Do not do the following

- Connecting or disconnecting the AC adaptor
- Pressing the power switch
- Touching the keyboard, touch pad, touchscreen (only for model with touchscreen) or external mouse
- Closing the display
- Turn on/off the wireless switch

NOTE

- To conserve power, the following power saving methods are set at the time of purchase.
 - The screen automatically turns off after 15 minutes of inactivity.
 - The computer automatically enters sleep^{*1} after 20 minutes of inactivity.

^{*1} Refer to  *Reference Manual* “Sleep or Hibernation Functions” about resuming from sleep.

- Note that the computer consumes electricity even when the computer power is off. If the battery pack is fully charged, the battery will fully discharge in the following period of time:
 - When power is off: Approx. 8 weeks
 - In sleep: Approx. 3 days
 - In hibernation: Approx. 4 days


At the time of purchase, “Wake Up from LAN” is enabled.

If “Wake Up from LAN” is disabled, the period of time in sleep will become slightly longer, and the period of time in hibernation will become about the same as during power-off. Even if “Wake Up from LAN” is enabled, when the LAN cable is not connected, the period of time in sleep and hibernation will be slightly longer.

- When the DC plug is not connected to the computer, disconnect the AC cord from your AC wall outlet. Power is consumed simply by having the AC adaptor plugged into an electrical outlet. Power consumption in each mode is as follows. (When AC adaptor is connected)
 - When the screen is off: Approx. 13.6 W
 - In sleep: Approx. 2.0 W
 - The battery pack is fully charged (or not being charged) and the computer is off: Approx. 0.9 W

■ To change the partition structure

You can shrink a part of an existing partition to create unallocated disk space, from which you can create a new partition. This computer has a single partition in the default setting.

- ① Click  (Start) and right-click [Computer], then click [Manage].
 - A standard user needs to enter an administrator password.
- ② Click [Disk Management].
- ③ Right-click the partition for Windows (“c” drive in the default setting), and click [Shrink Volume].
 - The partition size depends on the computer specifications.
- ④ Input the size in [Enter the amount of space to shrink in MB] and click [Shrink].
 - You cannot input a larger number than the displayed size.
- ⑤ Right-click [Unallocated] (the shrunk space in the step ④) and click [New Simple Volume].

First-time Operation

- ⑥ Follow the on-screen instructions to make the settings, and click [Finish].
Wait until formatting is completed.

NOTE

- You can create an additional partition using remaining unallocated space or newly creating unallocated space.
- To delete a partition, right-click the partition and click [Delete Volume] in the step ③.

Regarding Windows Vista


You can select the Classic view of Control Panel or the Classic Start menu. You can also change the way a user logs on or off. This manual explains using the Windows Vista default setting (not Classic view or Classic Start menu etc.).

● User Account Control


User Account Control is a new security component of Windows Vista to stop unauthorized changes to your computer.

The User Account Control message will pop up every time you try making an important change to your computer.



● Windows Sidebar

The Windows Sidebar does not appear in the default setting. To display it, click  (Start) - [All Programs] - [Accessories] - [Windows Sidebar].



To always display the sidebar:

- ① Right-click the sidebar icon  on the notification area, and click [Properties].
- ② Add a check mark for [Start Sidebar when Windows starts] and click [OK].

● When Using Wireless LAN <Only for model with wireless LAN>

If you cannot communicate with the access point or if the access point is not detected, right-click  on the notification area and click [Connect to a network], and then click  in the [Connect to a network] screen.

● Sound and Video

- Sound (e.g. MP3, WMA) and video (e.g. MPG, WMV) recorded in PC Cards and SD Memory Cards may be interrupted during playback. If this happens, copy them to the hard disk drive and play back.
- Sound and video in AVI files may be interrupted or produce a time-lag during playback. If this happens, click  or  on the notification area, and click [High performance]. This may remedy the problem.
- Depending on the processing status on Windows, sound may be interrupted at Windows startup. You can mute the sound at startup.


- ① Right-click the desktop and click [Personalize] - [Sounds].

- When you play back DVD-Video and other motion image files, the images may not be played back smoothly.

● If high-frequency sound occurs around keyboard while using the computer


This symptom is mitigated by changing the settings for the USB power saving function.

A standard user needs to enter an administrator password and click [OK].

- Set [USB selective suspend setting] to [Enable].
 - ① Click  (Start) - [Control Panel] - [System and Maintenance] - [Power Options].
 - ② Click [Change plan settings] of the current power plan.
 - ③ In [Change settings for the plan:], click [Change advanced power settings].
 - ④ In [Advanced settings], double-click [USB settings].
 - ⑤ Double-click the displayed [USB selective suspend setting].
 - ⑥ Change settings of [On battery:] and [Plugged in:] to [Enabled].
 - ⑦ Click [OK] and exit the [Advanced settings] screen.


● Windows Update

You can update to the latest patches and service packs for Windows with the following menus.

 (Start) - [All Programs] - [Windows Update]

Do not apply "Driver Updates" even if a message to update a driver appears. If a driver update is required, contact your technical support office.

● If the message "Check your computer security" is displayed

Select  (red icon) on the notification area and make the appropriate settings. The Windows Security Center regularly gives you notice so that you can make the optimum settings. This is not an error message and you can use the computer. However, making appropriate measures is recommended to reduce the risk of virus and other attacks.

Storage: -20°C to 60 °C {-4 °F to 140 °F}
 - Humidity: Operation: 30% to 80% RH (No condensation)
Storage: 30% to 90% RH (No condensation)
- Even within the above temperature/humidity ranges, using for a long time in an extreme environment will result in the product deterioration and will shorten the product life.
- Do not place the computer in the following areas, otherwise the computer may be damaged.

To clean the LCD panel

Hard Disk Data Erase Utility

When disposing the computer or transferring the ownership, erase all hard disk data in order to avoid data leakage. Use the hard disk data erase utility to erase the data completely.

Note that transferring of the ownership without uninstalling the commercial software will be a violation of the software's license agreement.

The hard disk data erase utility erases data using an overwriting method, but there is a possibility that due to malfunctions or other operational errors, data may not be completely erased. 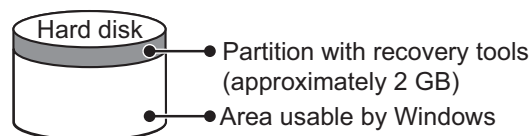
Reinstalling Software

Reinstalling software will return the computer to the default condition. When you reinstall the software, the hard disk data will be erased.

Back up important data to other media or an external hard disk before reinstallation.

During the diagnostic check, do not remove the AC adaptor, or attach any peripheral devices.

2 Turn on or restart the computer, and press **F2** while [Panasonic] boot screen is displayed.

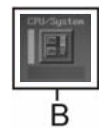

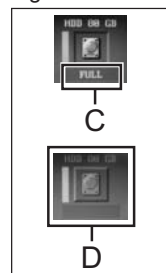
